

UNDERTAKING*

I, named _____, seeking admission to 2nd year/3rd year/4th year/5th year of B.A.,LL.B.(Hons.) / LL.M. 2nd year (strike off whichever is not applicable) hereby clearly understand that ragging** in all its forms is a heinous criminal act and therefore, it is strictly prohibited on and off NALSAR Campus for all times.

I further understand that ragging in any form shall make me liable to

- a) Immediate arrest, Criminal Prosecution and Conviction.
- b) Also to strict disciplinary action by NALSAR University and the punishment may include:
 - i) Suspension
 - ii) Minimum fine of Rs.10,000/- and a Maximum of Rs.50,000/-
 - iii) Rustication for a minimum period of one year or permanent expulsion from NALSAR University.

Any student, who has been criminally convicted of the offence of Ragging or punished by NALSAR in terms of fine of Rs.20,000/- or more, shall stand permanently expelled from NALSAR and debarred from joining any other educational Institution or University and / or seeking employment in the Government or Semi-Government Undertakings.

It is further understood that ragging is a very heinous crime and a serious violation of Fundamental Rights to Life, Liberty and Dignity under the Andhra Pradesh Prohibition of Ragging Act, 1997 (A.P. Act 26 of 1997) and the Rules notified thereunder and the Supreme Court directives. Ragging shall not be tolerated in any form under any circumstances and the perpetrators and abettors shall be liable to arrest, criminal prosecution and conviction in addition to disciplinary action and punishment by NALSAR.

Having understood the aforesaid Legal consequences arising out of every form of heinous offence of Ragging, I hereby undertake not to indulge in any form of ragging and/ or abet or help others in any manner in acts of Ragging on or off NALSAR campus. I also undertake not to enter any time of the day or night any Hostel allotted to First year students of B.A.,LL.B.(Hons.) during July and August 2011 and my mere presence there shall be deemed to be an act of ragging by itself and it shall carry a mandatory fine of Rs.10,000/- and/or suspension from classes and hostel for 15 days or more. No student of 2nd, 3rd, 4th, 5th Year / LL.M. II year shall call any student of First Year to his / her hostel / hostel room or any other place inside or outside NALSAR campus. If the University finds me guilty of Ragging or abetment of Ragging, the University may register an FIR for my arrest and Criminal prosecution and may also take disciplinary action.

* The signing and submission of the undertaking is mandatory for every student who is seeking admission for 2nd year, 3rd year, 4th year and 5th year of B.A., LL.B.(Hons.) course and LL.M. II year for the session 2011-12, failing which no student shall be allowed to pay his/her fees, seek admission and/or to attend classes and get Hostel accommodation. **Students should attach this Undertaking with the Demand Draft towards Payment of fee and Mess advance.**

** Ragging includes display of noisy, disorderly conduct, teasing, rough or rude treatment, indulging in rowdy, undisciplined and obscene activities which cause or are likely to cause annoyance, undue hardship, physical or psychological harm or mental trauma or raise apprehension or fear in a fresher or other students, or forcing a student to do any act which such a student is not willing to do or which cause him / her shame or embarrassment or danger to his / her life or limb, or indulging in eve teasing.
