Qualifications Required:

Junior Assistant

 Graduate in any subject from a reputed University having adequate knowledge in computer applications.

Candidates with shorthand / knowledge of operating accounting packages with knowledge of MS Office will be preferred. Preference will be given to the candidates having relevant experience in reputed universities / Institutions.

Staff Nurse

 Diploma in General Nursing and Midwifery or B.Sc. Nursing from a recognized University / Institution and registered as Nurse in State Nursing Council Register. Candidates should have atleast two years of experience in a reputed hospital or nursing home.

Record Assistant

 Candidates with Matriculation and having atleast five years of experience in a reputed University / Institution in the support management service.

Preference will be given to candidates having work experience in libraries.

For all the above positions, preference may be given to candidates with higher qualifications, relevant experience and having fluency in English language both written and oral.

Salary:

The basic pay in the pay scale for the said post as per the Telangana State Government pay scales will be paid as consolidated pay.

GENERAL INFORMATION:

- 1. The University may conduct written test / skill test any one or both, as method for shortlisting of candidates or alternatively the University may constitute a Screening Committee to scrutinize the applications and short-list the candidates.
- 2. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him / her for being called for interview.
- 3. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed; or by any other condition that it may deem fit.
- 4. Call letters will be sent only to the short-listed candidates and no correspondence will be made with applicants who are not short-listed.
- 5. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview.
- 6. The selected candidates do not have any claim / right for regular appointment in the service of the university.
- 7. Canvassing in any form on behalf of any candidate will disqualify such a candidate.
- 8. Incomplete applications in any respect shall not be considered at all.
- 9. No interim gueries regarding call letters /test / interview / selection will be entertained.
- 10. The University reserves the right to fill all the positions advertised or fill only some of the positions or not to fill any of the positions.
