### ABOUT THE JOURNAL

The Indian Journal of Intellectual Property Law (IJIPL) is India's sole student-run journal wholly devoted to intellectual property law. Published annually, it was first conceived as an idea in 2007 by the students of NALSAR University of Law, Hyderabad as a forum for the expression of ideas on intellectual property law by students across the country. As this vision grew, it was felt that the IJIPL must not just document student scholarship but must also serve to boost the intellectual property academia in the country. Therefore, the IJIPL strove to make available to its audience a wide range of eminent scholarship from across the globe. This has been amply reflected in the journal's first two volumes.

The force behind the IJIPL is its five-member student Editorial Board which is assisted by an Advisory Panel comprising of several renowned experts in the field of intellectual property law such as Prof. John Phillips, Dr. Peter Ganea, Prof. Shamnad Basheer, Joseph M. Beck and Pravin Anand. The IJIPL's success is, of course, also owed to the patronage of the Vice-Chancellor of NALSAR, Prof. (Dr.) Veer Singh and Hon'ble Mr. Justice U.C. Banerjee through the resident N.C. Banerjee Centre for Intellectual Property Studies. Now in its third year of publication, the IJIPL enjoys an outstanding reputation amongst law students and scholars alike. Its endeavour remains to foster this reputation and establish itself as among the premier intellectual property law journals in the world.

### PUBLICATION POLICY

The IJIPL publishes articles, essays, notes, comments and book reviews. All students, practitioners and scholars of intellectual property law are encouraged to

contribute under any of the above heads. However, undergraduate students may not submit book reviews.

The IJIPL promotes original scholarship. Therefore, all manuscripts sent to it must consist of original thought and research. Further, the manuscripts submitted must neither be previously published nor under consideration for publication elsewhere whilst being considered for publication in the IJIPL. No manuscript containing any form of plagiarism shall be considered for publication. The decision of the Editorial Board in this matter shall be final. The Editorial Board of the Journal shall not be responsible for any libelous or scandalous matter and the author shall be deemed to have obtained the permission of the referred author in case the work is unpublished.

#### COPYRIGHT POLICY

The copyright in the contributions accepted for publication therein shall remain jointly with the contributor and the IJIPL. Any person desiring to use the IJIPL's material for educational purposes, research or private study can do so with prior written permission of the Editorial Board.
