## 6. ACADEMIC PROGRAMMES

# A) Consortium of National Law Universities (Prof. Faizan Mustafa, Vice-Chancellor, NALSAR as President)

The Consortium of National Law Universities was established on August 19, 2017 with the aim of improving the standard of legal education in the country and justice system through legal education with Prof. R. Venkata Rao, erstwhile Vice-Chancellor, NLSIU as President and Prof. Faizan Mustafa, Vice-Chancellor, NALSAR, as Vice-President. During the year under report, Prof. Faizan Mustafa was elected as the President of the Consortium.

Besides conducting the admission test for the graduate and post-graduate programmes of the participating National Law Universities (NLUs), the Consortium aspires to facilitate better coordination amongst NLUs to achieve highest standards of legal education in the country. Twenty-One National Law Universities have joined the Consortium as founder members.

Under Prof. Mustafa's Presidency, on October 17, 2018, a permanent CLAT Secretariat was established at Bangalore. The Consortium became the legal entity by registering itself at Bangalore under the Karnataka Co-operative Societies Act on March 26, 2019.

Some major decisions about CLAT-2019 were taken by the Consortium during October, 2018. Keeping in view that in last few years there have been glitches due to the fault of the service provider in the conduct of the online CLAT examination, the CLAT Consortium decided to conduct CLAT-2019 Off-line. A permanent website of CLAT has been created and CLAT Secretariat has been functioning throughout the year from its permanent office in Bangalore. In the LL.M. admission test, some subjective portion was included in 2019 PG CLAT. To improve the quality of the question paper of CLAT, the Consortium resolved to create a question bank to which experts from all the NLUs and other institutions would be asked to contribute.

The Consortium also decided to hold a workshop in collaboration with NAAC and UGC on evolving objective parameters for the accreditation of NLUs by NAAC and other accreditation agencies.

In October, 2019 meeting, Consortium took several historic decisions. The Consortium decided that the CLAT – 2020 will change the pattern of the questions for the UG admission test. The idea of CLAT is to get better students to National Law Universities who have competence in reading texts and demonstrate skills in inferential reasoning. It was resolved to

reduce the number of questions from 200 to 120-150 questions. The Consortium felt that asking students to answer 200 questions in 120 minutes is not right as it puts students under lot of mental stress. Prof. Mustafa has been raising this issue in earlier CLAT meetings as well. The exam will remain off line and the duration will be two hours even for 120 or 150 questions. Comprehension based questions would be asked from Quantitative Techniques, English, Current Affairs, Deductive Reasoning and Logical Reasoning.

Similarly, the PG Admission Test will also have comprehension-based questions. The descriptive portion will remain same as last year. The Consortium has authorised the Executive Council of CLAT–2020 to study the possibility of introducing cut off marks for the LL.M.

The Consortium also resolved to undertake several Faculty Development Programmes in various member NLUs and launch a scheme of Scholarship / Fee Concessions for the students of NLUs. The Consortium would also assist the member NLUs in upgrading their library, IT facilities and other infrastructure.

NALSAR as President of Consortium therefore contributed to bring in major changes in the conduct of CLAT and in better co-ordination and co-operation amongst all National Law Universities.

# B) Review of Clinical Programmes

A Committee consisting of the following members to suggest measures for improving the Legal Aid Clinics of the University was constituted by the Vice-Chancellor:

- Prof. Neta Ziv, Academic Director, The Israel Affordable Housing Center and the Housing, Community and Law Clinic at Faculty of Law, Tel Aviv University - Chairperson
- 2. Prof. Amita Dhanda, Professor of Law, NALSAR
- 3. Prof. K. Vidyullatha Reddy, Professor of Law, NALSAR
- 4. Prof. N. Vasanthi, Professor of Law, NALSAR
- 5. Mr. P. Ashwini Kumar, Assistant Professor, NALSAR

The report prepared by the Committee was considered by the IQAC and after detailed deliberations in the IQAC, the recommendations made by the Committee were sent to the Academic Council and Executive Council of the University for their approval. The recommendations include:

- The existing Clinical Courses which are offered as mandatory will now be offered as taught courses. The Moot Clinic will be offered for 2 credits.
- The mandatory Clinic papers will now have 14 credits instead of 16 credits as per the following scheme:
- I Year : Moot Court Clinic (2 credits) over two semesters;
- IV Year : Legal Ethics and Accounting (3+1 4 credits)

- IV Year : ADR (4 credits)
- IV Year : Drafting, Pleading, Conveyance (4 credits)
- The elective clinics proposed under new scheme will have a class size
  of 20 students and would be taught over two semesters with the total of
  eight credits as their work cannot be completed in the short duration of
  one semester.

The Academic Council and the Executive Councils of the University at their meetings held on March 1, 2019 and March 16, 2019 considered the report submitted by the Committee for improving the Legal Aid Clinics of the University.

The IQAC, Academic Council and the Executive Councils approved the suggestions made by the Committee. The Academic Council has also recommended that the University should develop the parameters for evaluation of the proposed elective clinics as the students work outside the supervision of the teacher like paralegals. It was further suggested that the University may have collaboration with State Legal Services Authority and NGOs to allot work to the students under the Clinics. University may also think of having Start-up for Entrepreneurs as one of the practical Clinic. The works undertaken by the students under the clinics should be pro bono. It was also suggested that the University may conduct Faculty Development Programme to improve the skills of the Faculty for teaching the clinical courses.

Accordingly, the clinical programmes were revised and new clinics were introduced during the academic year.

## C) 5-Year B.A., LL.B. (Hons.) Degree Programme

## Admissions (2019-20)

The admissions for the twenty second batch were made through Common Law Admission Test-2019 conducted by Consortium of National Law Universities where 61859 candidates applied out of which 56246 candidates took the test on May 26, 2019. 123 students were admitted to the B.A., LL.B. (Hons.) degree programme including 53 girls. Among the students admitted, three students from Nepal, one student from Bangladesh, one student from Afghanistan and eight students from USA were admitted under the Foreign Nationals category. The remaining 110 students admitted to the course are from 20 different States in the country. The academic session started on July 2, 2019.

# Examinations (2014-2019 Batch)

End-Semester examinations for the B.A., LL.B. (Hons.) (2014-2019 Batch) were held in the last week of April, 2019 where **78 students appeared for the end-Semester examinations and 77 students cleared** the said examination. The B.A.,LL.B.(Hons.) Degree was awarded to the successful candidates at the Annual Convocation held on July 27, 2019.

# D) One Year LL.M. Degree Programme

## Admissions (2019-2020)

Admissions for the 18<sup>th</sup> batch (7<sup>th</sup> batch of the one year LL.M. programme) of the LL.M. Degree programme were made during the year under report through the Common Law Admission Test- 2019 conducted by **Consortium of National Law Universities** where 7728 candidates applied out of which 6586 candidates took the test on May 26, 2019. 63 students including 32 Girls were admitted at NALSAR. The students admitted are from 19 states across the country. Among the students admitted, one student each from Guyana, Nigeria and Tunisia were admitted under the Foreign Nationals category.

## Examinations (2018-2019 batch)

Out of 64 students admitted to the one-year LL.M. programme in 2018, 61 students have submitted their dissertations in the month of April, 2019. In addition, one student from the previous batch also appeared in the examination during April, 2019. In total, only 60 students (including one previous batch student) became eligible for the award of LL.M. Degree. The degrees were awarded to the eligible candidates at the Annual Convocation held on July 27, 2019.

## E) 2-Year M.B.A. Degree Programe

The two year full-time campus based M.B.A. Program is offered through Department of Management Studies with major specialization in 'Court Management'/'Corporate Governance'/ 'Financial Services and Capital Markets'/ 'Innovation and Sustainability Management'/ 'Operations Management' and minor specialization in 'Marketing Management'/ 'Human Resource Management'/ 'Business Regulations'.

The Department of Management Studies aims at crafting & delivering "Impact-Driven Education" that provides learners essential skills to solve managerial problems through the application of theory, technology and presence of mind. At the heart of our effort, exists, a drive towards invoking experimentation and the spirit of inquiry. To that effect, the DoMS faculty engages in learner centric pedagogical innovation. Expectation mapping and structured outcomes form the foundation of all programs offered by DoMS, NALSAR.

The Department has acquired an Academic Information System (AIS) to improve student engagement with the course curriculum. The AIS covers features of Notice Board, Online Learning Pedagogy, Online Quizzes and Forum Board among many other student engagement tools. The Faculty is actively engaged in preparing content to suit the online Pedagogy.

Under the ongoing 'i-Connect' Program, the Department has organized five 'i-Talk' sessions with Industry experts covering various functional

areas of the management to connect the students with industry to enable them to learn contemporary and relevant business practices.

Further, the Department has constituted 'Academic Advisory Board' and also 'Industry Advisory Board' with highly experienced and reputed members to provide guidance in framing Industry relevant syllabus and pedagogy.

Progress is a continuous process and it takes effort, dedication and thought. Department of Management Studies in its endeavor for the same has appointed after a rigorous intake procedure some of the best minds to help us achieve our goal of creating thought leaders.

## Admissions (2019-2021 Batch)

Admissions for the 7<sup>th</sup> batch of the MBA for the batch 2019-21 were done through CAT/XAT/ CMAT/GMAT/GRE and also NALSAR's Management Eligibility Test – 2019 (N-MET). 51 students were admitted including 29 Girls. The classes for the current batch (2019-21) commenced on July 01, 2019.

# Examinations (2017-19 Batch)

Examinations for the fourth batch of students of MBA 2017-19 were conducted during April, 2019. A total of 34 candidates have become eligible for the award of the MBA Degree and the Degree was awarded to the candidates at the Annual Convocation held on July 27, 2019.

## F) Integrated LL.M.- Ph.D. Programme

The University received 37 applications for admission to LL.M., Ph.D. Degree Program during the academic year 2019-2020. Out of the 37 candidates, 28 candidates appeared for the written test on May 18, 2019. 15 candidates cleared the test and they were interviewed by the Committee constituted by the Vice-Chancellor on June 9, 2019 and three candidates were admitted into the LL.M., Ph.D. Degree Program in the academic year 2019-2020.

## G) Ph.D. Degree Program

The University received 159 applications for admission to Ph.D. Degree Program for the academic year 2019-2020. Out of the 159 candidates, 85 candidates have qualified UGC NET/ JRF and hence, they were exempted from taking the Admission Test. 74 candidates appeared for written test and only 25 candidates have qualified the test.

There were 19 candidates who have passed the Ph.D. Admission Test in 2018 but their proposals were rejected in the interview. As per the Ph.D. Regulations, the candidates were given one more chance to submit their proposals. 85 candidates who were exempted from taking the Admission

Test, 25 candidates who have qualified the Admission Test and 19 students (2018) were asked to submit the Preliminary Proposals. Out of 129 candidates, only 90 candidates have submitted their preliminary proposals. The preliminary proposals submitted by the candidates were run through Turn-it-in software and three proposals were found plagiarized.

All the 87 proposals were sent to the Research Committee Members for evaluation. The Research Committee has by majority approved 25 proposals. Out of 25 candidates, 21 candidates made presentation before the Research Committee on November 1, 2019 and 12 candidates were admitted.

# Research Methodology Workshops organized for the Ph.D. Scholars

- Prof. Amita Dhanda, Prof. Vasanthi Nimushakavi, Dr. N. Manohar Reddy and other faculty members organized a 2-week long Ph.D. Research Methodology Workshop at NALSAR from February 25 to March 09, 2019. It was attended by twenty one Scholars. Resource Persons for the said programme include Prof. Faizan Mustafa, Prof. Amita Dhanda, Prof. Vasanthi Nimushakavi, Dr. KVK Santhy, Dr. Neha Pathakji, Dr. Harathi Vageeshan, Mr. Jagteshwar Singh Sohi, Dr. Murali Karnam, Dr. Uma Maheshwari Chimirala, Dr. N. Manohar Reddy, Prof. Sheela Prasad (University of Hyderabad), Dr. V. Janardhan (University of Hyderabad), Dr. Bhangya Bhukya (University of Hyderabad), Dr. Anindita Majumdar (IIT, Hyderabad), Dr. Shilpaa Anand (BITS, Hyderabad), Dr. Aparna Chandra (NLU, Delhi), Dr. K. Lalitha (Thinksoft, Hyderabad), DR. Raheel Dhattiwala and Ms. Shagufta Bhangu.
- Prof. Amita Dhanda and Dr. N. Manohar Reddy organized a 2-day Ph.D. Research Methodology Workshop on Ethnography from June 22 to 23, 2019 at NALSAR. It was attended by fifteen Ph.D. Scholars. Resource persons include Dr. Anindita Majumdar (IIT, Hyderabad) and Dr. Shefali Jha (University of Hyderabad).

### Ph.D. Thesis submitted

Mr. Mohd. Owais Farooqui, Ph.D. Scholar submitted his thesis and on the recommendation by the external examiners, the viva-voce examination was conducted on July 23, 2019. The candidate successfully defended the thesis in the public viva-voce and became eligible for award of the Ph.D. Degree. The Ph.D. Degree was awarded to him at the 17<sup>th</sup> Annual Convocation held on July 27, 2019.

### H) Directorate of Distance Education

NALSAR University of Law established as an Institution of Excellence in Law, ranks as a premier Institute in the country with a multidisciplinary approach to Law, offering Graduate, Post Graduate and Research Degrees. The University apart from its regular programmes has established a niche for itself

in outreach programmes by offering diploma and post-graduate degree programmes since 2001 and its Directorate of Distance Education (DDE) has been offering Master's and PG Diploma programmes through Open and Distance Learning mode on emerging and contemporary areas from almost last two decades

During the reported year, Prof. Faizan Mustafa continued as Officiating Director of Directorate of Distance Education.

University has been graded as Category-I University as per UGC (Categorisation of Universities (Only) for grant of Graded Autonomy) Regulations, 2018 due to which the University has the autonomy to offer programmes through Open and Distance Learning (ODL) Mode without approval of the UGC.

Taking advantage of the Category – I status, the DDE, NALSAR introduced seven (07) new programmes during the academic year 2019-20 in addition to the existing six (06) programmes which were offered in the previous academic year.





# I) Advance Post-Graduate Diploma in Industrial Security, Law and Management to the trainee Assistant Commandants of NISA

As per the MoU entered into by NALSAR and NISA-CISF on December 6, 2017 the Advance Post-Graduate Diploma in Industrial Security, Law and Management was offered to the trainee Assistant Commandants of NISA.

The Second batch admissions took place during this year and a total of 13 Trainee Assistant Commandants were admitted to the Advance P.G. Diploma Programme during September, 2019.

# J) Post-Graduate Diploma in Industrial Security, Law and Management to the Trainee Sub-Inspectors

As per the MoU with NISA-CISF, the Post-Graduate Diploma in Industrial Security, Law and Management was offered to the Trainee Sub-Inspectors of NISA.

Admissions for the second batch were made during September, 2019 and a total of 53 Trainee Sub-Inspectors were admitted to the P.G. Diploma Programme.

# K) Programmes offered by Cyber Forensic Lab (Ctrl-Z)

NALSAR University of Law in collaboration with Cycops has established a inhouse cyber forensic facility by name Ctrl-Z with 15 work stations, cyber forensic hardware tool kits both software and hardware, display panels and virtual cyber forensic lab. The main objective of the Lab to offer short term, long-term and practical hands-on training programmes for the legal practitioners, administrators, policymakers and law enforcement authorities on cyber laws and cyber technologies.

During the year under report, Ctrl-Z conducted a 5-day Programme on Computer Forensic Investigation from October 18-22, 2019. The Ctrl-Z will be offering the following programmes during January – February, 2020:

- A 5-day programme on Computer Hardware and Networks for NISA Trainees officers during January 20-24, 2020.
- A 3-day programme on Hands on Forensic from February 26-28, 2020.

## 7. INTERNAL QUALITY ASSURANCE CELL (IQAC)

During the year under report, the IQAC constituted by the Vice-Chancellor was ratified by the Academic Council and the Executive Council at their meetings held on March 1, 2019 and March 16, 2019 respectively. The Council's further extended the term of the IQAC till April 11, 2020.

## A) Meetings of the IQAC

During the year under report, the meeting of the IQAC were held on February 6, 2019; February 26, 2019; June 20, 2019 and November 19, 2019.

The IQAC considered the report submitted by the Committee consisting of the following members to suggest measures for improving the Legal Aid Clincis of the University:

The IQAC considered the report of the Committee and recommended to the Academic Council and the Executive Council for their consideration and approval. The IQAC also considered the Manual of Policies for MBA prepared by the Department of Management Studies and suggested modifications. The modifications suggested include reducing the number of credits required for completion of the course and criteria for award of specialisation; to reduce the pressure on the students suggested to reduce the number of examinations. The modified Manual of Policies has been approved by the Academic Council and the Executive Council in March, 2019.

The IQAC also detailed out the proposed action plan for the University for the academic year 2019 – 2020.

#### 11. LIBRARY

Library is spread across an area of 54,323 Sq. Ft. There is a separate enclosure with carrels for students. All the house keeping activities are automated and are powered by VIRTUA of VTLS Inc., and the Library has adopted Radio Frequency Identity (RFID) based solutions for its circulation, management, inventory and security systems. The students are provided with RFID equipped identity cards. The Library is also equipped with an Orientation Room with Projector, Discussion Rooms and Moot Court Rooms on the first floor. ## **Acquisition**

### Printed Books

There has been significant growth in the collection of printed as well as Electronic resources during the last year. The growth in the printed resources was largely due to astute participation of members of faculty and Library Committee and regular liaisons with the subject experts. By the end of this December, the collection of printed resources totalled to 41282 which includes the CJHR, CES, MBA, Bare Acts, bound back volumes of Periodicals and Donations . New accession during the year are 940. The Library expresses its gratitute for generous donations received about 184 books from its patrons Mr. P.Balakrishna Murthy, Tinatha Raju, NALSAR Faculty Members and students etc.

#### MBA Library

There is a separate section for the MBA collection on the top most floor of the library. This floor is equipped with books on one side and reading tables and chairs on other side with sufficient ventilation and natural light.

## UN Collection

As a Depository Library of UN Collection, it has received substantial resources of major organs of UN. The collection of 462 books are housed in an exclusive location in the first floor.

## • Print Journals and Electronic Resources

Library continued its renewal to Indian and International resources in print and electronic format which include Taxman, SCC Online, LexisNexis India, Kluwer Arbitration Law Online, Hein Online, Manupatra, Westlaw, JSTOR, J Gate database and Ezproxy softwares. In addition to the above E-resources, the University subscribed to Bar and Bench and EBC Reader (for disabiled students). Apart from the renewal of the existing print format the university also subscribed to print Journals like AIR Power Journal, Defence and Diplomacy and Journal of Aerospace Sciences and Technologies.

## NEWS Papers



## • Library Internal Meetings

Library internal meetings are held before starting of semester wherein we discuss about strengthening the library resources, the developments, pest control, changes to be done, Library timings, duties of staff and cleanliness in the library etc.

## Additional Infrastructure provided in Library

- SELF CHECK (KIOSK): A Self Check Station was procured from 2CQR in the month of August 2019, so that students can issue and return the books on their own.
- <u>Printer/Xerox Machine</u>: An additional printer cum photocoping machine was procured for the students in the Library as a standby and to reduce the rush in the peak hours.
- <u>Computers</u>: Three new computers were procured in the library for the staff.
- <u>Disability access:</u> A ramp was constructed adjacent to the library for the Disabled students.

## 12. IT INFRASTRUCTURE

### Wi-Fi Upgraded:

To meet the increased demand which is due to the increase in number of admissions in various courses, the Wi-Fi was upgraded by adding another 24 access points and summing upto 108 access points into a single controller. This Wi-Fi upgradation was integrated with new sets of firewall routing and filtering policies which abides with NIC privacy

infringement and copyright challenges. By this integration the total coverage of Wi-Fi in the campus is 70%.

## **Automation of Live Streaming:**

Centralized live streaming console has been established with portable video encodes and cameras on roll and also upgraded our HD Cameras to UHD/4K Cameras and increase the quality of the video output to 2146 P resolution on both Vimeo, Facebook and YouTube.

#### e-Learning Studio

In order to the growing demand for visual e-content and visual e-learning materials we have established a state of art e-Learning Studio with multi camera setup for catering the requirements. The established e-Learning Studio develops contents by using ultra key VFX effects which integrates multimedia graphical content with teaching learning methodologies.

#### Digital Notice Boards

As part of digital initiatives all the standalone physical notice boards have been replaced by 55 inches digital display panels which are centrally connected to multimedia server. This facility enables for display of University events, activities, academic programme schedules, achievements of students and teachers. Being digital display panels different kinds of graphically driven digital contents shall be mounted and displayed seamlessly.

#### NALSAR YouTube Channel

Continuing the initiation of enhancing the digital presence of the University, the official YouTube channel bearing the name 'NALSAR University of Law' has been updated by uploading recordings of guest lectures as well as sessions that are part of conferences, workshops, training programmes. Some of the guest lectures were planned with the help of student groups. It must also be highlighted that the University also uploaded the recordings of the short courses taught by foreign experts. As of now, there are more than 600 videos available on this channel, with nearly 26000 subscribers and **one million views**. In the coming years, the University aims to upload more content which will help us in the dissemination of legal knowledge. ## The CBP cell analyzer (Erba -H-360):

The equipment is useful in analyzing quickly the complete blood picture. With this equipment the results will be quick and accurate. With this equipment the delay and the human errors in the results, when the test is done manually can be avoided.

## BET 449. IFT - TENS-STIM-ULTRASOUND Physio therapy equipment.

With the help of this machine, physiotherapy to muscle and tendon sprains can be done. In case of sprain or any other muscle issues, there is no physiotherapy centre available near the campus, hence, to facilitate the residents, the equipment was made available in the Health Centre itself.

National Conference on 'The Courts and the Constitution - 2018 in Review' on January 26 – 27, 2019

A National Conference titled 'The Courts and the Constitution – 2018 in Review' on January 26-27, 2019 was organised under the aegis of the 'Centre for Constitutional Law, Policy and Good Governance' and 'MK Nambyar SAARCLaw Centre for Advanced Legal Studies' at NALSAR in collaboration with the School of Policy and Governance, Azim Premji University, Bangalore and the editorial team of the 'Law and Other Things' Blog. This programme consisted of eight thematic sessions with a total of 24 invited speakers drawn from the judiciary, practitioners, academics and journalists. Full details of the programme are provided under the Centre for Constitutional Law, Policy and Good Governance.

#### Two-day Law and Religion Conference

NALSAR University of Law, International Center for Law and ReligionStudies, Utah, USA and South Asia Consortium for Religion and Law Studies jointly organized a two-day Law and Religion Conference from February 29, 2020 to March 1, 2020 at NALSAR.

Supreme Court of India has finally decided the long pending Ayodhya case in November, 2019. It has also referred the Sabrimala issue to the nine judges' bench which will soon hear the matter. The court is reconsidering the whole essentiality test. The Court while pronouncing

its order on the Sabrimala review, has also referred the issues of Muslim women's entry in mosques, of a Parsi woman who has married outside her community's right to attend funeral ceremonies, and of Dawoodi Bohra's female genital mutilation to this bench. The conference was organized to provide an important occasion to discuss these cases and the following sub-themes:

- a) Indian courts and religious property disputes—most notably, the Ayodhya Mosque case, but very possibly others.
- b) Access to sacred sites (temples, mosques and shrines etc.). This would involve the *Sabrimala* case and other cases in which secular courts have entered rulings about who is entitled to enter (or decide upon entry) into temples or other sacred sites. The Supreme Court is indeed reviewing Sabrimala judgment.
- c) Constitutional issues raised by the national register of citizens that make citizenship and rights claims hinge (either de jure or de facto) on the religious status of those seeking registration.
- d) Anti-conversion laws and case law addressing the constitutionality of such laws. The Supreme Court recently gave four weeks to centre on the petition of Dalit Christians. They are not extended the affirmative action or reservation benefits. The Presidential Order of 1950 is a clear case of discrimination solely on the basis of religion.
- e) An issue close to the foregoing two cases is the question raised by a case decided about a year ago that overturned denial of special Indian visa status to an individual of Indian descent who had been trained in the U.S., and had then returned to India to provide medical work, on the ground that he sometimes shared his religious beliefs with patients and others.
- f) Decisions regarding prayer or other religious observances in schools. On January 24, the Kerala High Court denied religious education even in private unaided non-recognized schools. In 2019, all central government funded schools were directed to have prayers in the schools. The matter is pending with the Supreme Court.
- g) The Triple talaq decision and other personal law issues. PILs are pending in the Supreme Court on polygamy etc.
- h) Other similar issues that raise law and religion and/or religious freedom questions.

Dr. Shilpaa Anand has been appointed as Distinguished Research Fellow at Centre for Disability Studies at NALSAR. She has a Ph.D. in Disability Studies from the University of Illinois at Chicago and an M.A. in English from the University of Hyderabad. Her research interests include literary and cultural disability studies, historiography of disability and culturally different concepts of corporeality. In her doctoral work she explored the conceptual history of disability in the Indian context.

Having worked at different universities in Hyderabad since 2009, she has previously taught courses in literary theory and criticism, cultural studies, comparative literature, nineteenth century fiction as well as American literature. Her papers have been published in edited volumes on disability studies in India and South Asia as well as in scholarly journals. She moderates a lively email list called Disability Studies India and has co-edited multiple issues on disability of the web magazine *Cafe Dissensus*.

 'Fostering Research in Disability' - Winter School conducted by both <u>Centre for Disability Studies and BITS – Pilani, Hyderabad campus from</u> <u>December 16-21, 2019</u>

A Winter School on 'Fostering Research in Disability', the first of its kind in India, was jointly organized by the Centre for Disability Studies, NALSAR University of Law, Hyderabad and Department of Humanities and Social Sciences, BITS-Pilani Hyderabad Campus from December 16 to 21, 2019. Prof. Amita Dhanda (NALSAR) and Dr. Shilpaa Anand (BITS) served as Program Co-ordinators. The week-long Winter School engaged with questions of disability with a special focus on voice, representation and participation of disabled people in law-making and cultural processes. Thirty participants were selected out of the 130 applications received in June. Winter School attendees included research scholars and early to mid-career faculty members from different parts of the country and abroad, researching in the fields of Humanities, Social Sciences and Law. About fifty percent of the participants were people with disability.

Resource persons included disability scholars from the disciplines of Law, Literature, Sociology, Social Work and Anthropology. Speakers appraised participants of significant developments in the field of disability research and introduced them to topics within the field which merit research such as: a) legal and cultural disability exclusions and inclusions- legally embedded and culturally enabled; discourses of human rights and social justice; c) 'voice' and 'representation' within disability studies scholarship. Few research programs in the country

cater to researchers in disability studies while the application pool demonstrated that there is a steadily growing number of academics interested in the field. As a response to this situation, the Winter School on disability research has been proposed as an annual collaborative event between the two institutions.

## Co-hosted the 19<sup>th</sup> Basic Income Earth Network Congress from August 22-25, 2019 at NALSAR

The most significant activity undertaken was to co-sponsor the conclave of Basic Income Earth Network. The conclave was an opportunity for the University to reach out to scholars, activists, grassroot organizations in other parts of the country and the world to understand how the values vital to the project were being understood and executed by other individuals and organizations in other parts of

the world. The project and its philosophy were shared with the delegates in a plenary panel which resulted in a number of delegates proactively reaching out to us. Thus, the strategy of proactively reaching out to likeminded scholars and activists launched in the first year of the project was further strengthened by having all the doctoral scholars attend the conclave and forge relevant scholastic connections. Julio Linares and Gabriela Cabana-Alvear - delegates at the Basic Income Conference – presented their paper on reimagining the nature of money as currency. Their approach to alternative economics and degrowth presented us with a huge learning opportunity and has inculcated an interest in the care economy and feminist economics among some of our scholars. Prof. Phillipe Van Parijs, one of the progenitors of basic income theory, was yet another contributor at the Conference who offered critical interventions, as one who has studied the political and economic theory underlying the basic income. They served as valuable reminders that advocacy for the universal basic income is a separate project from academic and empirical research that test the basic income in social contexts other than developed economies. Indeed, the former must be grounded in ethical research carried out in social contexts in the global south as well.

In order to advance the values informing the project the next generation was exposed to the values of care and cooperation. Consequently, an intensive course on basic income was offered at NALSAR by Prof. Phillipe Van Parijis. More than hundred undergraduate and post-graduate students attended the course. In addition, all the doctoral students sponsored by the project attended the course. The induction of these values in the course curriculum has helped in drawing us closer to the above stated outcomes.

The Centre in collaboration with Tel Aviv University organized the workshop on 'Creating Conversations: From CSR Practice to Precept' during February 9-10, 2019. This workshop aimed to map and discuss available models of collaborations and legal and regulatory approaches towards Corporate Social Responsibility (CSR) that may serve as catalyst for business to target great outcomes for people and the planet too. Research Project on 'Farm Animal Protection: True Cost of Eggs Series' funded by HSI India

The animal protein production sector in India has undergone a paradigm shift in its structure and operation from being a mere backyard activity in most cases, into a major commercial agriculture-based industry over the period of four decades. In the west emerging research into the sector has shown that the environment, public health and animal welfare have suffered greatly because of industrialised animal husbandry. There is little to no research from Indian to highlight the animal welfare issues, negative externalities and public health cost associated with the rapidly growing sector. This series will shed light on some aspects of the sector by looking into the labour rights, animal welfare, public health issues associated with the egg production sector.

India ranks 3<sup>rd</sup> in the world in egg production according to Watt Executive Guide, 2015. Commercial poultry farming in India has created and still creating a profitable business opportunity for business runners. The demand for eggs in the market is never-ending but at what cost? Through this paper series you will see it is at the cost of people employed in these farms, at the cost of the environment, at the cost of the birds that supply these eggs, at the cost of the local/surrounding neighbourhood and last but not least at the cost of you! What are you consuming, where is it coming from and at what cost?

The first paper in the series will give an account of the labour rights violations in egg production facilities in and around Hyderabad. The second paper will focus on documenting the condition of birds in egg production in Telangana. The last two papers will highlight the environmental and public health issues associated with egg production because of the lack lustre regulatory environment in Andhra and Telangana. Telangana and Andhra are two regions where the bulk of India's egg production happens and thus grounding the research in the region would be Ideal.

This paper series aims to increase insight into the following:

- How the current system of battery cages and treating the birds as "production units" leads to immense harm not only to the birds but also to the labour and other humans in and around the poultry farms on a regular basis.
- How intensive confinement has an adverse impact on not only the animals but also causes a wide range of problems for our environment. The waste is released to our water bodies without any treatment. Our water and air quality are drastically compromised because of these industries. Studies have found that the workers of poultry farm report a more frequent occurrence of "headache, runny nose, sore throat, excessive coughing, diarrhoea, burning eyes, chest tightness."
- The prevalence of child labour, bonded labour and other labour rights violation in the visited poultry industries.
- What are the immediate measures that the poultry industry would need to take in order to improve the working conditions and address the existent human rights violations?

### Labour Paper

- The paper has been written with insights gained from 25 field visits to egg production facilities.
- The paper is in the last stages of review and will be publication ready by 15<sup>th</sup> November.

#### **Animal Welfare Paper**

- The paper is being drafted with insights gained from 25 field visits to egg production facilities.
- 50% of the paper has been drafted and it should be ready for publication by 30<sup>th</sup> December.

- To build a health profile of people living in zones where egg production is concentrated by partnering with public health agencies and local doctors.

## Five Day Refresher Training Programme for Advocates of Telangana

## 1<sup>ST</sup> NALSAR-UNICEF IHL AND CHILD RIGHTS COMPETITION

To mark the 30<sup>th</sup> year of The Convention on the Rights of the Child (CRC), NALSAR's Centre for Child and Youth Justice, in collaboration with UNCIEF, organized this competition to encourage students to deliberate on the intersection of International Humanitarian Law and Child Rights.

The oral rounds of the 1<sup>st</sup> NALSAR-UNICEF International Humanitarian Law and Child Rights Competition, 2019 were held on the April 13-14, 2019. It witnessed 15 teams participating against each other. Each team represented various roles such as Ministry of Home Affairs, UNICEF, Ministry of Defence, Office of Prime Minister etc.

The teams advanced their arguments based on the competition problem and the simulation problems which were released 45 minutes before each round. There were four preliminary rounds after which six best teams qualified for semi-finals.

After the semi-finals, the three best teams qualified for finals and competed against each other in front of a five judge bench comprising of Ms. Suroor Mander (Centre for Equity Studies), Prof. Danushka S Medawatte (Professor, University of Colombo, Sri Lanka), Prof. Shantha Sinha (Professor, Hyderabad Central University), Ms. Ashley S Kinseth (Founder, Stateless Dignity Project) and Ms. Juhi Bansal (IHL Course Instructor, National Law University, Delhi).

#### 19. RECRUITMENTS / INTERNSHIPS

## A) Undergraduate Programme

NALSAR graduates enjoyed an outstanding placement record. International and national law firms, corporates, PSUs and government agencies came for campus recruitments with highly attractive pay packages.

The students of the batch were placed with national / international law firms, banks, and corporates. Job placement for all graduates who opted for it has been 100%.

### Internships

NALSAR believes that learning is not done in the classroom alone but also at place of work. To give practical insight, the University has systematic student- run winter and summer internship programmes. The students of the B.A., LL.B. (Hons.) and LL.M. Degree Programmes went for internships with government and non-governmental organisations, national and international legal corporates, senior lawyers and law firms. Some students worked as interns (Law Clerks) with the Hon'ble Judges of the Supreme Court and High Courts. Internship Placement is made keeping in view the preferences and aptitudes of the students in terms of what sort of employment they look for. Orientation training is given to the students to prepare them for placement with different organizations and the type of work which they are supposed to do as interns. After the internship is over, the students submit their reports to the University and these reports are taken into account for next internships.

During the year under report, the University provided financial support for the selected economically disadvantaged students on the basis of their family income for their internship. A total amount of Rs. 3,10,500/- has been sanctioned to the students who applied for the said programme during this year based on the recommendations made by the Committee constituted for this purpose.

## B) Master's Programme - MBA

The alumni of DoMS, NALSAR are presently working with reputed organizations like Byju's, Karvy, ICICI, Vodafone, SCSA Governance, Axis Bank, Modor Intelligence, Infinity Research, Avetti Commerce, Stratagem, Core Compete, Franklin-Templeton, Shemford Schools, TCS, Eco System Talent sprints and Lemon Tree Hotels etc. During this Year, The placement Committee elections were held in September in the presence of concerned Faculty Members and students. The Department of Management Studies has started a Training & Placement Advisory Cell. Eleven functional Committees, viz., Academic; Alternative Dispute Resolution; Moot Court; Literary and Quizzing; Cultural and Fine Arts; Mess and Hospitality; Hostel and Campus Welfare; Debating; Sports; Social Responsibility and Student Welfare and the Board of Auditors were elected. The new office bearers for the year 2019 took oath of office on August 8, 2019.

The office bearers of the SBC for the year 2019-20 are Balaji Naik Azmeera (President), Joshi Sughosh Digambar (Vice-President), Rathod Uma Mahesh (General Secretary-Male), Sawant Hemali Sandeep (General Secretary-Female), Krishnanunni U (Joint Secretary-Male), Shagun Bhargava (Joint Secretary-Female) and R Kavipriyan (Treasurer).

## B) Academic Committee:

During the year under report, the Academic Committee undertook the following activities:

- In collaboration with the student welfare committee, a scholarship committee to review the scholarship policy had been set-up. Representation was sent from the Academic Committee to the scholarship committee. Continuous deliberation and assistance is being provided by the Academic Committee. A major point among the latest changes made to the scholarship policy was to make it non-merit based and only depending on income level to make it more inclusive.
- An academic mentorship programme was set up for the first-year students. The mentors were appointed such that the students were given mentors who spoke a language they were comfortable with. The academic committee is reviewing the effectiveness of the programme through collecting feedback.
- The First edition of the IHL Competition was conducted successfully. The Organizing Committee for the 2<sup>nd</sup> International Humanitarian Law competition to be held in February 2020, was successfully set up. Rooted in the field of International Humanitarian Law, the competition intends to test the participants on their ability to understand real world conflicts, both from a legal and practical

perspective. NALSAR is the first Indian University to host such an event. The proposition for the competition has been approved by the UNICEF. Participants in the competition will be screened on the basis of their knowledge in IHL and their CVs. Selected candidates will send in written submissions on a problem involving a fictional international conflict. Each team, of two or three members, will represent each of three sides, namely the government, non-state armed groups and the international community in their written submissions and their oral rounds, which will be held in a semi-formal, round-table format.

- The open challenge for the 33<sup>rd</sup> edition of the Jean-Pictet competition was successfully conducted by the Committee. The team comprising of Maitreyee Dixit, Dayaar Singla and Aashna Chowdhary cleared the Open Challenge for the 33<sup>rd</sup> edition of the Jean-Pictet competition. A total of 48 teams will be selected across the world and on selection the 33<sup>rd</sup> edition of the Competition will take place in Denpasar (Indonesia) from February 22-29, 2019.
- The Academic Committee is working along with the Editorial Board of the Volume XIII of the NALSAR Student Law Review for the release of the 2<sup>nd</sup> NALSAR Student Law Review Symposium on Law and Public Health.
- The academic committee is working with the IT department and the library to overhaul the library website to improve its user interface.
- The academic committee has created a list of books and e-resources worth Rs. 2.3 crore and has proposed to procure the same for the library.
- The academic committee has worked towards making reference material for mandatory courses more accessible by digitizing such materials.
- The academic committee has effectuated infrastructural improvements to the campus library. Additional plug points and LAN ports were installed, additional tables and chairs have been ordered and a breach between two moot court rooms was sealed.

# D) Alternate Dispute Resolution Committee

The ADR Committee performed the following duties during the year under report:

- The committee successfully organised the official NALSAR Mediation Tournament, the first inter-collegiate ADR Tournament to be contemplated in NALSAR, one of the biggest mediation competitions in the country. Preparations are already underway to organize 2020's edition of the competition, and to make it the biggest and the best mediation competition in the country.
- The committee applied for slots at ICC Hong Kong Mediation Competition, and for the first time, for any national university, was allotted two slots in the prestigious competition.
- The Committee organised the Open Challenge for the ICC Hong Kong Mediation Competition, which involved the participation of four teams, and included a judgment on the written submission as well as on the simulated mediation. The Committee organised not only the judge for the same, but also the official mediator.
- The Committee applied for the ICC Paris Mediation Competition, and for the second consecutive time successfully secured a slot for NALSAR University of Law in the competition. The application process involved a multi-layered process of not only re-creating the NALSAR Student Achievement in ADR database which comprised of an updated version of all student achievements in ADR and Arbitration Activities, but also a detailed account of all the ADR related courses offered and taken by NALSAR Students over the course of the various student exchange programs, to ensure the most accurate representation of NALSAR's ADR potential.
- The Committee created and oversaw the organising committee for the conduction of the annual NALSAR Selection Mediation-Negotiation

- Competition, 2019 for the allotment of various domestic mediation & negotiation competitions, in which over 120 students participated.
- The committee organised the Annual Client Counselling Selections for the allotment of various domestic client counselling competitions, in which over 40 teams (80 students) participated).
- The Committee prepared the annual budget for ADR Activities, and created a new Sanctioning and Allotment policy to improve upon the previous years and provide for a more equitable allotment of competitions: such a policy, for instance, only allowed for preference to be given to Selection Teams for competitions officially mentioned in the Selection Pool so as to prevent confusion. The creation of the Sanctions Policy ensured that students are wary of the official withdrawal dates for open challenges and selection competitions, to ensure a smooth process and an equitable conduction of the various competitions.
- The Committee successfully organised the Open Challenge for ICC Paris, 2020 which involved the participation of over fifteen teams, and included the organisation of two highly esteemed judges and an official mediator.
- The Committee has organised numerous open challenges for domestic and international competitions, which require not only the drafting of a new problem (or a new set of confidential information) to ensure the best and most equitable experience for the participants, but has also relied upon a pool of qualified judges, while ensuring that issues of conflict do not arise in the process as well.

- The Committee has been consistently registering for international and domestic competitions, including INADR Toronto and The Negotiation Challenge, NUJS Mediation Competition, and the Brown Mosten Client Counselling Competition.

### I) Mess and Hospitality Committee

The Mess Committee for the Academic Year 2019-20 has set out with objectives of ensuring healthier food items on the menu in addition to ensuring a hygienic Dining Hall. In continuation of past practices followed by the Committee, the Mess Committee for this year has relied extensively on student feedback to determine the menu. To that end, regular surveys were conducted in which the student committee had a decisive say in changes to

the Mess Menu. Furthermore, the Mess Committee, to ensure accountable usage of the resources it provides to Fest Committees, has instituted an accountability mechanism that requires the detailed submission of the entire expenditure towards the organization of the Fests. The Mess Committee has also been a bridge between the student community and the Mess Contractor, regularly conveying the requests and grievances of the student community. The committee has also continued the practice of funding the distribution of sweets on festivals. The Mess Committee has undertaken green initiatives like discontinuing the usage of disposable paper plates for steel plates. Furthermore, the Committee intends to completely phase out the usage of paper cups for beverages by the end of the academic year 2019-20.

# J) Social Responsibility Committee:

The function of the Social Responsibility and Student Welfare Committee has been carved out to help improve and allow smooth access to various kinds of infrastructure facilities and measures that would make their student life comfortable. All the year round, there has been continuous co-ordination with the IT Department of the college to make sure students are able to access Wifi and internet facilities. In addition, laptops were bought for to be used by the students, for a temporary period. This was an important addition to the facilities, since many students faced problems, when their laptop would require sudden repairs around the time of examination or assignment submission. Cycles on campus (which are rented out for a nominal amount) were repaired several times and purchase of new cycles from the annual SBC budget was made. Purchase of law textbooks too was done utilising the SBC budget, and distributed to students from various years. Also, efforts are being made to make a book bank of digital copies of the book, to be made available to all students. Clothes collection drive was successfully carried out, for donation of clothes to Goonj Foundation. The NALSAR Legal Aid group successfully carried outs its activities for the year, which is partly funded from the SBC budget. College merchandise for the students was made available at subsidised rates. Further, as part of student initiative blood donation drive was conducted in the month of February in collaboration with Aarohi blood bank.

The General Body membership, where students get to participate in the working of the committees on voluntary basis, for all the SBC committees was carried out. In addition, the 'Student-Mentorship' exercise was also carried out, by allocating senior students as mentors to the incoming first year students. Provision was made in the budget to have a separate amount to fund voluntary student run initiatives on campus which is now in the process of allocation.

# K) Scholarships Awarded

 Khushi Mittal, Aryan Garg and Aniket Chauhaan were selected for award of Aditya Birla Scholarship by Aditya Birla Group each year for the five year period. The criteria for selection was divided into two rounds: First round included the submission of the Application and the essays. After the first round, a certain number of students were

- shortlisted for the final round on the basis of their application and essays. The final round was organised in Mumbai which was an interview with a panel of eminent lawyers and justices.
- During the year under report, 11 students have received the Aditya Birla Scholarship (Renewal).
- NALSAR also provided financial assistance to the students by way of scholarship / fee concession for 20 students of B.A., LL.B. (Hons.); 12 students of LL.M. and nine students of M.B.A. during the year 2019-20. The selection is on means-cum-merit and merit-cum-means basis. A total of Rs. 28,64,000/- was spent towards providing financial assistance to the students.

# L) Cultural Committee

- Once a week committee organizes this Theme Thursday by sending out a mail providing a particular theme like traditional, Back to School, Goth. Twinning Thursday, etc. Theme Thursday were held on July 4, 2019, July 10, 2019, July 18, 2019, July 24, 2019, September 5, 2019, September 24, 2019.
- Antakshari Night is just you need to sing your heart out where people are divided into 4/5 teams depending upon the number of people and the event will have rounds based on the themes and at the end the winner team gets the prize. Antakshari Nights were held on July 11, 2019 and September 9, 2019.
- Karaoke Night organized by the committee on August 6, 2019.
- The most loved, most awaited and highly demanded event DJ Night was held on September 12, 2019 where we arrange speakers, lights, DJ and decorate DoMS for the students to come and dance and enjoy to the fullest.
- Dandiya and Garba Night happened during Navratri on October 1, 2019 where the cultural committee provided dandiya sticks and had an amazing garba night.
- Two week Photography Competition was held from September 14-28, 2019 in which the students were told to click pictures based on two themes Common theme for all participants i.e. Life at NALSAR and second is the individual and there were exciting prizes given away to the winners.
- Rangoli Competition happened during Diwali on October 8, 2019 where again the winners for the best Rangoli were given cash prizes.
- During Diwali Celebration the committee decorated the campus with lights and diyas as well as brought some fire crackers on October 26, 2019.

## M) Student Outreach:

## NALSAR Litigation & Advocacy Project

NALSAR Litigation & Advocacy Project (NLAP) is a student run initiative, founded by Dayaar Singla, Bhavish Kaki and Vishal Rakhecha working for increasing legal aid and advocating for various social causes since September, 2018. The project has grown to over 10 students and receives guidance from Prof. (Dr.) Faizan Mustafa, Vice-Chancellor, NALSAR in his capacity as the Director of the Project. NLAP assists lawyers with pro bono or public interest litigation by providing assistance in terms of researching and drafting. NLAP's Public Policy vertical works towards creating change through measures that do not involve the judicial arm of the government.

NLAP's Litigation vertical has closely worked with lawyers including Mr. Aman Wadud, in Assam on various cases which deal with the arbitrary decisions of the Foreigners Tribunal, pertaining to the citizenship issue. In collaboration with the well known multinational non-profit iProbono, India run by NALSAR alumni Ms. Swathi Sukumar it released a Foreigners Tribunal Lawyers' Training Module. It is also working with Hyderabad based lawyers on matters of privacy, Aadhar and surveillance.

The Policy vertical, had the honour to be invited to testify before the US Trade Representative (USTR) on the Special 301 Report in Washington D.C. where the Project argued for a better status for India and removal of our country from the Priority Watch List. NLAP also worked on a report with the renowned US based non-profit Avaaz on the issue of fake news and misinformation. The Project has also worked with Save Life Foundation and assisted in research and legal drafting for proposed amendments to the Central Motor Vehicles Rules, 1989. Further, NLAP worked with Legal Initiative for Forest and Environment (LIFE) on creating a database of cases on Biological Diversity Act, 2002 and in preparation of a report on the status of its implementation with special focus on South India.

At NALSAR, we also held a documentary screening for 'Between Hatred and Fear: Surviving Detention in Assam', and held a discussion with Leah Verghese, (NLSIU, Columbia). NLAP is NALSAR's another step towards furthering the University's objectives.

## **DEVISE-** Developing Inclusive Education

Currently, there are 110 volunteers for DEVISE who take turns to conduct English training sessions for the underprivileged children on a regular basis in the villages near Shamirpet. The group established a 'Reading Room' at Zilla Parishad High School, Pudur with around 700 bilingual books (Telugu and English). It also established a Community base for Education (CuBE) in

Muneerabad where the volunteers conduct English training sessions regularly after school hours. Nearly 100 children are benefiting from these activities currently.

## Legal Aid Group

The NALSAR Legal Aid Group (N-LAG) which has around 45 members, has carried out the following activities during 2019-20 under the leadership of P Avinash Reddy and Benjamin Vanlalvena:

- Prepared a booklet on Panchayti Raj Act for training Sarpanches in Telangana
- Carried out a door-to-door awareness campaign about Domestic Violence Act in Pudur village
- Conducted a Legal Aid Camp at Pudur village and Legal Awareness Camps in Muneerabad
- Visited refugee settlements in Hyderabad and interacted with the refugees to understand their access to basic amenities
- Collaborated with Save The Children and UNHCR and prepared a comprehensive training module on domestic laws for refugees in India
- Conducted training for the staff of Save The Children about the various domestic laws
- Assisted in organising the World Refugee Day Commemoration Event on July 18-19, 2019 in collaboration with Save The Children
- Attended State-Level NGO Meet on NREGA, its failures and lack of implementation.
- Went to Eturnagaram for Legal Aid Work, focusing on Tribal Land Rights (1959 AP Act) and filing complaints related to SC/ST Prevention of Atrocities Act.
- Met and contacted stakeholders and persons involved regarding Transgender Persons Rights, in respect of Right to Food, and other laws and policies.

# IDIA (Increasing Diversity by Increasing Access)

Beginning this year, the IDIA group at NALSAR conducted more than 200 hours of CLAT coaching classes in the Jan-May period, with the help of numerous volunteers from NALSAR University and also with the support of full-time interns who joined us from other colleges at Sai Junior College for the Visually Challenged. By CLAT 2019, our trainee had been given 525 odd hours of classes. This hard work of the volunteers and interns paid-off, when our trainee at the said Junior College made it to WBNUJS, a premier law college of the country. Another trainee, Akhil, also made us proud by getting selected to National Law University, Orissa. He was being trained by a reputed coaching institute, Career Launcher, which has a training collaboration with IDIA. The training operations were resumed in June 2019, to help the selected trainees prepare for CLAT 2020. The team is currently

training eight students to appear in CLAT 2020. Out of these, five have been secured enrollment in Career Launcher. For the remaining three, more than 250 hours of training sessions were conducted with the help of the volunteers from NALSAR University and full-time interns from other law colleges. These trainees come from various social backgrounds, and some of them are also differently-abled. This is in line with the goal of making law schools truly accessible.

These operations of the organization are partially funded from the funds raised through on-campus fundraising programs. The IDIA team at NALSAR University raised more than Rs. 40,000 of funds through various events, conducted with the help of volunteers. Among others, the group conducted 'Bake-Sales', where the in-house student 'chefs' prepared food delicacies, and helped the IDIA group raise upwards of Rs. 10,000. The group also reached the alumni and distinguished legal professionals for support.
