**NOTE:** The papers must be within these broad themes but the **topics enlisted there-under are not exhaustive.** 

It is with great pleasure that the Centre for Aerospace and Defence Laws would like you to submit abstracts/papers on any of the above mentioned themes to the **Conference Convener** by **26**<sup>th</sup> **JANUARY**, **2020**. All the selected abstracts will be published in a Conference Souvenir. Authors of selected Abstracts shall submit final papers by **30**<sup>th</sup> **April**, **2020**. Selected full length papers will be published in NALSAR's Indian Journal of Air and Space Law/ Edited Book.

NOTE: The abstract should be **not** more than **400-500 words** and the full-length paper shall not be more than **5000 words**, including footnotes.

#### **GUIDELINES FOR THE PAPERS/ABSTRACTS**

- 1. Briefly introduce your topic.
- 2. Elaborate the importance of the topic and its relevance.
- 3. Try to raise as many as legal/policy issues.
- 4. Last part of the abstract should reflect the research scheme of your entire paper.
- 5. The mandatory formatting specifications for the papers/abstracts are: 1-inch margin on all sides; Times New Roman typeface with 12-point font size; and 1.5 line spacing.
- 6. For footnotes, the mandatory formatting specifications shall be: Times New Roman typeface with 10-point font size; and single (1) line spacing.
- 7. Authorities must be cited throughout the paper using the format provided hereunder as Annexure-I.
- 8. PLAGIARISM: Plagiarism is cause for immediate disqualification. The original content limit shall stay above 80 percent.
- 9. The copyright of the entry to the Journal will rest with the Editorial Board once the entry has been selected and the authors(s) of the same have been notified.

<u>Note:</u> Kindly note that the abstract would be considered as a criterion for the selection process for the full-length paper.
